1. Approval of minutes from meeting held 6th April 2022 – Agreed and signed.

 1. Re playpark. Emma Howells confirmed the preferred equipment from previous communications with the supplier. Cllr Williams clarified this and received an amended quote.

She will clarify with the equipment provider the terms by which we agree and secure the current quote on the understanding that we are still not responsible for the area. Other issues regarding the additional area of land that was to be included needs resolution as it appears the neighbour has acquired more than we were led to believe from the outline plans sent to us. Cllr Howells also informed the meeting that there may be offers of manual help with preparatory ground work. TBC.
