Part 1 – Invited guests Jessica Lawrence, neighbourhood policing team and Carwyn Rees of Owen and Owen

Jessica requested the opportunity to meet with the community Council to introduce herself and hear about any issues we have as a community. The key issues relate to traffic volume and speeding through the village. Jessica agreed to see what could be done in terms of monitoring speeding.

Carwyn Rees came to inform us of plans to improve the Point Rd. It is hoped that with support from PCNPA, RNLI, community funds from Energy initiatives, and possibly the Community Council, a more sustainable solution to improving and maintaining the road can be achieved. It was suggested that the RNLI are the main users of the road but ACC indicated that it is visitors; also, that funds from Energy initiatives would not be available until projects have been approved completed which could be some time. Carwyn did not have any costs for improvements to share with us at this stage. ACC raised concern regarding the potential to increase the speed at which vehicles use the road, which is already an issue.
