#### 2. Declarations of Interest

#### 3. Welcome

The Chair, welcomed the large number of members of the public to the meeting. Condolences were offered to the clerk following the recent passing of his father. The meeting was reminded that the AGM will take place at the meeting due to be held on 11 July 2022.

### 4. Questions from the Public

- 22/0140/PA Land to North of Freystrop Cross
  - A long discussion took place concerning this variation to planning submitted under Section 73.
  - Council were informed that following the granting of the original planning conditions relating to hours of work were not observed. Out of hours working has been noted on weekends and bank holidays. Residents have received abuse and threats when trying to collect evidence to back their assertions leaving them afraid to report to the authorities.
  - Some residents reported not having received notification of this planning application.
  - It was mentioned that although the size of the development was somewhat smaller than originally proposed the positioning of the plant room had been moved closer to Cavalier House.
  - A discussion about previous planning and a history of the site was held.
  - Senders of letters of objection to the approved planning application had received no acknowledgement and the objections were not recorded.
  - Planning enforcement is deemed to be 'non existent'.
  - Council were requested to respond to the application citing the following issues:
    - Increased noise
    - Increased traffic and the dangers to other road users which Highways appear to have ignored
    - Hours of operation
    - Light pollution from the car parking
    - Apparent lack of environmental assessment
    - Devaluation of the contiguous properties and managed a
