# WISTON COMMUNITY COUNCIL

**Minutes** for the Community Council meeting held on Monday 18<sup>th</sup> July 2022 at 20:00hrs at the Memorial Hall, Clarbeston Road.

#### 1. Chairman's Remarks

The chairman welcomed everyone to the meeting.

#### 2. Apologies for Absence

Apologies were received from Thomas Bevan, Marilyn Bevan, and David Evans.

### 3. Confirmation of Minutes of the Last Meeting – 20<sup>th</sup> June 2022.

Minutes of the meeting held on 20<sup>th</sup> June 2022, were confirmed as a true record. Proposed by Peter and by David Howlett.

#### 4. Matters Arising There From

- a. Broadband Project Update: David informed the meeting that the work was continuing all be it slowly. There is a possibility that Clarbeston Road may be included in the New Moat Project, which could mean the village being connected a little sooner than estimated.
- b. Defibrillators: ongoing, no update at present.
- c. Parking on pavement in Clarbeston Road: update from Pembrokeshire County Council (PCC): Message from PCC Senior Traffic & Road Safety Engineer, Clare Williams – "Currently the Civil Enforcement Officers do not have the power to enforce when vehicles are parked on the pavements. Although WG promoted that HA would be equipped with the necessary powers to enforcement pavement parking (by May 2022) this has not materialised and therefore it is a Police matter. It should also be noted that the desired outright ban on pavement parking as promoted will not be the case. I think this is why there has been such a delay with the progress on this proposed legislation – it is not as straight forward as it first appeared! I.e., if pavement parking is enforced then in some location's vehicles will not be able to proceed along a public highway. Unfortunately, there is no highway type advisory sign available within the Traffic Signs Regulations and General Directions to advise motorists not to park on the pavement that can be placed on the public highway. (Note the grassed area is public highway according to our records). An advisory sign can however be placed on private land with the owner's consent. The lowered kerb line over the length of the scheme presents a confusing message to motorists and does not deter motorists from parking on what appears to be an extension of the footway. In a similar manner the provision of parking immediately outside the vets but obscuring the footway appears to be acceptable? There may of course be good reason for this i.e., land boundaries /ownership but all the same does present a mixed message and promote an unsafe route to reach the tactiles/crossing point. I have made a number of "ad hoc" drive thru site observations (5 in total) at various times of the day and not observed vehicles parked on the pavement other than in front of the vets. If motorists are completely blocking the footway as illustrated above, I would encourage residents to report these observations to the Police, who currently have the power to remove or issue a FPN at their discretion."
- d. Cleaning of the Railway Bridge in Clarbeston Road: David had a contact (Mark Carter) who could supply a water bowser and industrial pressure washer to get this work actioned at a date in the future. The overgrown vegetation at the T Junction would also be addressed, as Network Rail claim there is no issue with the growth.
