1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ £20.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

2. The £20.00 above relates to the payment of Poppy Wreath For the annual Remembrance service

3. The end of the year Bank balances at have risen slightly (£4,045.00) mainly due to underspend on Clerks salary due to retirement and failure to fill the vacancy as well as continued fundraising donations to refurbish the play park.

Due to delays in the acquisition of the land for the playpark, we have been unable to Order or make any payments (other than £400 towards solicitor fees for conveyancing for equipment. We hope this will be resolved in the next financial year. There has been no VAT reclaim and stationary cost have reduced slightly.
