#### 10. Highways & Rights of Way

- Targate Road
  - Request to designate the road as 'Access Only'
    - No response from PCC
  - Low hanging branches
    - Some work appears to have been carried out by private individuals
- CL/095 Two applications to apportion a Right of Common
  - Council had no issues to raise
- Public Path Diversion Order PP21/18 (Silverstream to Bower House, New Road)
  - The Definitive Maps officer had issued a public notice in the Western Telegraph re-routing the path
  - Following representation by by Mrs R Thompson a letter is to be sent to the officer outlining concerns about the route



# 11. Planning Matters

- 22/0140/PA Land to North of Freystrop Cross
  - Approved with conditions
  - On behalf of Mrs P Lowe Councillor E Utting raised the issue of what were considered to be acceptable operating hours at the site and whether conditions were being broken
  - PCC Councillor M J John advised should there be issues, that possibly should be brought to the notice of enforcement officers, these should be reported by the person(s) affected immediately. Evidence should be collected. An email should also be sent.
- 22/0287/PA 2 Silverstream
  - Extensions, Alterations and Widening of Existing Driveway
    - Refused
  - 22/0528/PA Resubmission 21/9/22
    - No issues were raised
- 22/0319/PA Middle Hill Farm Variation
  - It was observed that work was progressing and assumed to be to the original planning
- 22/0342/PA Summer Hill West
  - New 2 storey Dwelling with basement garage and wine cellar
    - The clerk has an interest in this submission and requested that the Chair carry out the digital consultation during the Council recess
    - The Chair submitted Council's comments to the Planning Support Team
    - · No decision upon the application has been made
- o 22/0369/PA Priory View Resubmission
  - Approved with conditions
- Councillor D S Harries reported that a bungalow was being constructed at Top Farm
  - This was the subject of a certificate of lawfulness in 2020 following a 1996 application
