1. Attendance & Apologies

2. Freystrop Village Hall Trustee Welcome

 W D Thomas welcomed everybody and explained the reasons for holding the Freystrop village Hall meeting separately from the Freystrop Community Council meeting this month

3. Presentations & Questions from the Public

O No members of the public were present and no questions had been submitted

4. Village Hall

- Main door repair update
 - Work is still required on the door and the craftsman is being chased. The door is, however, secure
- Car park extension
 - The FCC clerk had received no response to numerous requests for an update. W D Thomas had met representatives of BDS and been assured the transfer of ownership was with solicitors
 - W D Thomas had also raised concerns about the safety of the grill behind the fencing
- Village Hall Upgrade Project
 - D S Harries has received quotes for plastering and DPC
- Bookings
 - Bookings were stable, losses had been replaced
 - It was noted that a number of bookings had been lost through the lack of a separate disabled toilet
- Cleanliness
 - Informal comments had been received from the pilates group about dog hairs on the floor. D S Harries has polished the floor prior to pilates classes to ensure the group's comfort
- Services
 - It is unlikely that relief can be claimed on electricity costs. The current 3 year contract fixed price is below market price

5. Parc Hamdden Freystrop Recreation Park

- Picnic in the Park
 - The July picnic had a good attendance and was deemed a success
- Autumn activities
 - C & D S Harries planned to do some grass mowing on the paths and to clear obstructions on the hedge on Targate Gate to improve vision for vehicles exiting the park
 - Delivery of the next batch of trees from The Woodland Trust is due between 31 October and 11 November

6. Bus Shelters, Kiosk & Other Community Assets

- Discussion on telephone kiosk future use consultation response
 - The majority response was for a book exchange. The sanitation station would be relocated from the Hall to the Kiosk to facilitate this
 - Offers from residents to paint a mural on the shelter had been received
- Pembrokeshire Coast National Park Discovery Point Display Panel
 - R D Lavis proposed that the map be affixed to the rear wall of the shelter such there was enough space to also display a Freystrop specific panel
- Marquee hire contract update
 - No update. This was not deemed a priority a winter is approaching and the marquee is unlikely to be used
