V. Solar developments & renewable energy

Wogaston Solar Farm – The Community Contribution Fund was discussed. Application form is to be completed and posted off. Once the funds arrive, it was agreed to deposit these funds into the Angle Community Council account to begin, while a more appropriate account is researched and opened. The funds will be use for the good of the whole community, once received the Angle Council will be asking the community for suggestions/ideas as to where and how to best use these funds.

<u>Rhoscrowther Wind Farm</u> – Pembrokeshire County Council unanimously voted against the Application for the Wind Farm at Rhoscrowther. The developers now have six months to appeal this decision. At the time of our meeting, no responses have been received.

- a) <u>Angle Village School</u> The decision whether to amalgamate Angle Village, Stackpole and Orielton Schools has been postponed from March 2015 to May 2016 No changes are planned until then.
- b) <u>Footpath at Chapel Bay Fort</u> A question was raised regarding the upgrade to the entryway road / path to Chapel Bay Fort. If any work is planned, could PCC also look into a pathway from Chapel Bay Fort Entry Road to West Angle Bay Beach. Teresa to follow up and keep ACC updated.
- c) <u>Enterprise Zone</u> A request from Cllr Williams to invite the person/s in charge of the Enterprise Zone, to attend a special meeting to explain to the council why the boundary lines have changed in our area. Seconded by Cllr Brown. Teresa to follow up.
- d) <u>Lorries driving through Freshwaterwest</u> Recently a number of large lorries have been directed by 'satnav' to the Valero, Power Station and the new solar farm projects by way of Freshwarterwest. This is causing much confusion and damage to both bridge and lorries. A permanent width restriction sign has been placed at the entry way to Freshwest. Other signs are coming and will be placed on the 3 cross way to warn larger lorries not to continue.
