#### The Clerk/RFO presented the budget papers for 2019/20 and forecast for 2020/21. appx.c

Attention was drawn to the following issues which were felt required careful consideration when determining the precept for 2020/21:

i) Need for Election Contingency fund:- to cover cost of an election should the need arise. This was advised by the County Council in 2018 with a recommendation of £1200pa

Currently there are no funds earmarked for such an event, following discussion it was agreed that the Councils Contingency funds will be structured as follows:

- Welsh Language Act contingency fund £2920 (increasing at 10% pa)
- General contingency fund £4800
- Community Amenity Fund £3000
- Election Fund £2400

ii) Councillors Remuneration: - potential for payment of £150 per annum per councillor-which has been highlighted in previous meetings

iii) Rising general costs:- i.e increase in Clerk hours

iiii) Pembrokeshire County Councils continuing commitment to saving money and the potential for the Community Councils responsibility and therefore costs to increase.

After consideration of all funding requirements for 2019/20 and potential expenditure for 2020/21 it was decided to increase the precept to £7000. This was proposed by A. Lowe and seconded by S. V. Davies.

All members endorsed this decision.
