20.20 COUNTY COUNCILLORS REPORT

- Crundale hook farm - PCC are looking into the activity at Crundale Hook Farm, to ensure it meets all planning regulations. The enforcement officer has been in touch with the owners at the farm and they are expecting to submit a planning application, hopefully within a few weeks.
- Stevensford bridge – following some complaints about the surface of the bridge, PCC have inspected the bridge and found it meets all safety standards.
- Road to Hangar 5 – the road has been looked at and have found no issues with the middle of the road. The edges is breaking up and will be looked at, but will not be a priority based on the visual inspection.

21.20 RUDBAXTON COMMUNITY ASSOCIATION.

There was no monthly meeting, therefore the Community Association had nothing to report, but they have passed on their thanks to the Council for their assistance in purchasing the new chairs for the Community Hall

- I. Former Cllr, Tony Davies has sadly passed away. He was a Councillor for 18 years, serving the Council from May 91 until Sept 2009. During that time, he did have a short spell as Chairman also.
- II. Rosemary Lane – The Chairman discussed with the council, asking the Cty Cllr, to make enquiries with PCC regarding the removeable bollards in the lane. It seemed there was some evidence within the lane, that vehicles were accessing the lane and noted that the removeable bollards were no longer fixed in place.
- III. Speeding – it has again been brought to the council the speeding within the village. It seems more apparent, with more of us out walking from our homes, walking in and around the village. The Council agree, something has to be done within our community regarding traffic calming measures.
