78.21 MINUTES OF COUNCIL MEETING held Monday 15th February 2022

79.21 MATTERS ARISING FROM THE MINUTES

Disabled access to the hall: It has been established there is disabled access through the back door and this is accessible from outdoors with a key available. The Association are looking at alternative positions for the water on/off access point, as currently it sits at floor level and isn't easily accessible to all.

80.21 SPEED AWARENESS

PCSO-Donna very kindly attended our meeting. Donna gave us an update on the position of the community speed watch scheme; new equipment is on its way. This equipment will be stored at Haverfordwest police station. It can be collected and signed out by a nominated 'responsible person'. The scheme will also require 1 nominated person to input the data into the system via a link to the GoSafe website.

Several members of the community have already shown an interest and completed the relevant vetting forms. As soon as the forms/volunteers have been through the vetting process, the scheme should be up and running within 1 week.

There will be new signage that will be put up in the community.

Donna explained, that currently, there is no nominated PCSO for our area. A recruitment is underway, but for the meantime, Donna was happy to be a point of contact for the community.

82.21 Queens Jubilee

There is a funding application available which will be applied for, from the National lottery.

Depending on the outcome of this application, the association will then organise the event with the available funds .

Costings will be obtained for several things, including entertainment, icecream van, band and decorations.

*Dingle Close:- Upon completion of the site, the County Council adopted the roads, but not the verges. Ownership currently lies with the landowner. PCC will write to the landowner, requesting permission to takeover the land.

*Dog fouling:- Cllr Yelland has spoken to the local dog warden who is going to visit the area to see if there is anything further that can be done to deter dog fouling.

- *Withybush woods:- several damaged trees during the storm and some have been identified as having ash dieback.
- *Footpath, Rosemary close-Boot & Shoe close:- Ongoing, council now looking at the option of reducing the road layout to 1 priority system as opposed to the initial plan of 2.
- *Cllr Yelland will request the removal of the fallen tree and debris.

A question was put to Cllr Yelland, whether the road sweeper could clear the path from 'The old Post Office', down to the area where the bench and bin are. The pavement is heavily congested with debris from various sources and in places impassable by some.

Cllr Yelland was also questioned about the 106 money available to the community and how much was available.
