## 2. Declaration of Interest

No declaration of interest declared to the proposed Agenda (Monday 14th November 2022).

## 3. Approval of Minutes

Minutes of the meeting held at 19:30 on 10<sup>th</sup> October 2022 in Marloes Village Hall proposd, approved and signed by Marloes and St Brides Community Council vice chair (CJ) and seconded by cllr CT.

Minutes scanned and electronically archived by clerk (BC). Action points from the 10<sup>th</sup> October meeting discussed and completed.

## 4. Community Issues

4.1. Broadway Fibre Broadband

Broadway fibre optic poles have been erected on private lands without land owners permission. Broadway have been notified by National Parks (PCNPA) that the poles cannot be erected in high value landscape areas (this includes much of Marloes and St Brides). They need PCNPA permission. The community council believe no more poles are required by Broadway. Broadway can also use existing Western Power poles if needed (by can be a time consuming, paperwork driven process).

#### 4.2. Affordable Housing

Interest from ATEB in 5 to 10 new housing plots for re-advertised land – i.e. an extension to the Town Meadow Affordable Housing development. PCC have been consulted by ATEB. This is still with ATEB.

Cllrs CJ and PS explained the benefits of a supportive email as the last housing development took over 12 years complete. Community Council in full support.

#### 4.3. Village Green / Footpaths / Beach

Vicky Swell emailed by Cllr CJ (correspondence below). Community Council awaiting reply.

We have Community Council on Monday; could you please advise me re the following:

- 1. Any progress on the Clock Tower to Glebe Lane footpath improvements?
- 2. Musselwick Sands footpath: could you please research the possibility of a dog waste bin next to the gate off the road? This path was bad all summer, and now it seems that a lot of locals have decided that it is the perfect place to take their dog and not bother to clear up afterwards.

Cllr CJ pointed bought the issue of over 50 bags of dog poo being discarded in the Marloes Sands dog waste bins.

4.4. Recreation Area / Village Hall / Clock Tower

Mark Burton (Recreation Area Committee) has quote for the upgrade of the village parks play equipment (£4,000). The funds will be taken from the enhancing Pembrokeshire grant.

Community Council in full support. AP Clerk to draft letter of support for Cllr to approve / send in the next community council meeting (12<sup>th</sup> December).

Community Council highlighted the new total of the enhancing Pembrokeshire grant - £22,338. Highlighted the importance on spending the grant on the community.

#### 4.5. Highways

Cllr CJ emailed Claire Williams regarding carried forward action points (email correspondence below). Community Council awaiting reply.

- 1. Potholes on C3102 between West Hook and Martins Haven car park.
- 2. Speeding in Glebe Lane Marloes: could there be extra signage or speed bumps?
- 3. Foxdale campsite entrance, Glebe Lane Marloes: exiting vehicles do not check for traffic before pulling out. Should there be white lines?
- 4. Church Close Marloes: PCC name sign fallen into disrepair.
- 5. Glebe Lane Marloes: heights of hedges impairing road user visibility. Owners' obligations to keep trimmed.

Foxdale owners supported point 3 (campsite entrance issues). The owners happy to support community council to look at white lines, turning mirrors, speed limit signs, etc.

4.6. National Trust

Mark Underhill contacted – Marloes Mere project completed. AP Clerk to forward final reply from Mark Underhill to Cllr PS.

- 6.1. NP/22/0488/SCR National Trust: Trehill/Marloes Mere re-routing of track.
- 6.2. NP/22/0367/FUL Foxdale Guest House & Campsite Marloes Replacement toilet & showers, upgrade 5 touring pitches to mobile pods, change of use of redundant annexe and upgrade/replacement of ancillary static caravan.
- 6.3. NP/22/0314/FUL Philbeach Farm SA62 3QU Conversion of redundant RAF wireless building which has been used for agricultural storage but is now in a bad state of repair into holiday let use.
- 6.4. NP/22/0186/FUL Musselwick Farm Creation of new field access with new 4.6 metre wide gate on north side of road between Marloes & Martins Haven. Approved, but major discrepancy between stated method and approved plans.
- 6.5. NP/22/0240/FUL Lower Ripperston Farm, St. Brides, Haverfordwest, Pembrokeshire, SA62 3AH The proposed demolition of the modern farm buildings, and the construction of a replacement new build dwelling etc.

Cllr PS confirmed clock maintenance organised for the 17<sup>th</sup> November with Smith and Derby.

Cllr confirmed electricity bills for clock tower are increasing and the standing charge is high. Cllr suggested solar PV panels to support electricity cost (funded by the Enhancing Pembs Grant). Cllr CT to follow up with playing field committee and report back to community council next meeting.
