Name of Town or Community Council: Freystrop Community Council

Introduction and Context

- Freystrop Community Council's purpose is to benefit the local population. Assets of the council include the Village Hall and the Recreation Park. The shores of the Cleddau in the community are in the Pembrokeshire Coast National Park and adjacent to that is a large area of woodland managed by the National Trust. Some 30 acres of common land within the community boundary are managed by Pembrokeshire County Council who work with local graziers to safeguard the biodiversity of this area.
 - Development of the Recreation Park has begun to create a multi-use/multi-functional area for the local population with a bias towards nature conservation & enhancement. Grants have been received, with additional donations from local residents, for tree saplings. These have been planted in various parts of the park by local volunteers. Plans for a community orchard are underway with a number of crab apple and other fruit trees already planted. Dead hedging has been created to encourage wildlife.
 - Freystrop Recreation Park is at the furthest edge of the village on Targate Road and has an area of 6.5 acres 2.633 hectares.
 - Public service delivery the work undertaken is for the benefit and Wellbeing of Future Generations.
