3. Approval of Minutes

4. Community Issues

4.1. Broadway Fibre Broadband

Email received from Broadway Fibre Broadband and Pembrokeshire County Council:

Dear Marloes-St Brides Clerk,

Thank you for your email. I have discussed your project with Broadway and have asked them to provide a detailed update of the project. Please see the bottom of this email for their update.

As you can see a large proportion of the Marloes build part of the Dale project area is complete, with only 44 properties out of the 207 left to reach.

Broadway plan to reach those 44 remaining properties by the end of June as they have been held up at certain key sections.

Broadway Partners Wales Manager Reece Simmons is willing to attend a community council meeting. Would you be able to send a list of upcoming meetings, which we can forward to Reece at Broadway?

Just for clarification, there is no contract as such with Broadway. The wider Dale project area community chose Broadway Partners largely because they were the only network provider willing to take on such a rural build. Pembrokeshire County Council are not in a contractual relationship with Broadway Partners but we will continue to facilitate what we can and raise issues directly with Broadway that we feel need addressing. We regularly prompt Broadway to send the relevant communities the up to date technical build information, which only they have access to.

Update received from Reece Simmons -

"We have largely completed the build of our Marloes project with 44 properties left to get to which we are hoping to reach by the end of June (these are largely located in the region heading towards Wooltack Point). There reason that these properties have been delayed is due to not being able to get agreements from landowners but a key one was secured in the last couple of weeks, which is enabling us to progress.

We have passed 163 properties in our Marloes project to date all who have the ability to connect to our network, of these 163 properties we currently have just over 30 customers.

I would be happy to attend a community council meeting if needed but with my diary currently I may need to look a few months ahead."

Another point: the green/white emergency phone sign fixed at the top of the post has been weathered illegible – any chance it could be replaced, please?



4.4. Clock Tower

4.5. Highways

Clerk has set up a Marloes and St Brides online portal with Pembs CC to report issues easier moving forward.

Potholes across the community discussed and reported by Clerk on the Pembs CC website.

Clerk reported Cllr CJ email below to Pembs CC (via online portal).

Martins Haven: road access to beach from opposite WCs down to shore.

I was down there yesterday (3rd May), and there are three galvanised posts from which road signs have been removed. This is of concern, because of the need for emergency service access to the beach at all times.

4.6. National Trust

No new National Trust updates and no updates on the damage / repairs to the Car Park hut.

4.7. Treatment Plant

Foxdale Guesthouse and Campsite have emailed Welsh Water. Council are in support and Clerk has emailed Welsh Water to express their support of the email sent.

4.8. Rubbish Bin (used for household waste)

Cllr PS pointed out ongoing issues with rubbish bin misuse (reported to PS by local residents). Cllr will keep an eye on the rubbish bin in question and report back in next meeting.

Cllr Reg Owens was looking at a dog refuse bin go Musselwick path. Cllr LB recommend the National Trust could provide the new bin and Pembrokeshire County Council could empty the new bin.

Ongoing AP Cllr CJ to speak with Vicky Swell from the National Trust to discuss the new dog bin on Musselwick path.

4.9. Toilets

Clerk has replied to PCC recommending the National Park take responsibility at St Brides. The Community Council Cllrs will not be taking financial responsibility for the potential closure of the toilets.

No further updates from PCC, National Parks / Trust and Welsh Government on the toilet closure.

PCC made residents aware they will re-visiting toilet closures and funding following the local community dislike to the closure proposals.

4.10. St Brides Walled Garden

No further updates from PCNPA or Gary Meopham (following phone call with Cllr CJ).

Before anything else can happen the Park Committee members must visit the St Brides Walled Garden and Cottages to familiarise themselves with the land holding and its assets. Following this, PCNPA will arrange a joint meeting involving PNCPA, PCC, Community Council and the Church so that possible options can be discussed: different parties with very different agendas (emergency services, walkers, swimmers, divers, churchgoers etc) have to be accommodated at this very popular location.

Dear Mr Dennis

I was down Martins Haven yesterday...

- 1. The galvanised lifebuoy post with its concrete base has been torn out of the ground and is lying against the bank.
- 2. The lifebuoy appears denatured by exposure to sunlight and I suspect that it would come apart if anyone tried to use it.
- 3. The cord lacing round the lifebuoy ditto, and the long orange line.

I hope that something can be done about this soon

PCNPA Development Control:

NP/22/0488/SCR National Trust: Trehill Farm land at Marloes Mere re-routing of track. In process of consultation

NP/22/0314/FUL – Philbeach Farm SA62 3QU - Conversion of redundant RAF wireless building which has been used for agricultural storage but is now in a bad state of repair into holiday let use. Contrary to LDP Policy 7 – likely to be sent to Members under extended delegation for decision or a future Committee meeting

NEW NP/23/0233/FUL – Marloes Mere. Email recived from PCNPA (please see below). Community Council were supportive of the new plans and happy PCNPA had taken into consideration previous council ideas / suggestions.

Dear Clerk

I am emailing you to let you know that National Trust have recently submitted for full planning the scheme for improvements to the wetland and footpath at Marloes Mere.

FYI: We first brought to your attention in October 2022 (email conversation below).

As you know, this will come to your council for consultation in due course (with a full suite of drawings and papers). However, I thought I would email in advance on two points

1. To let you know that we have included a "tractor gate" as requested at point 4 in the email below from Chris Jessop in October 2022.

a. The attached drawing shows the style and location of the gate (just west of Runwayskiln and the permissive footpath to the coast).

b. The style was discussed and agreed with Anthony Richards (PCNPA Access Officer) and Gina Smithies (NT Tenant at Trehill Farm who access their fields along the lane).

c. Vehicular access along the track will be controlled via a locked farm gate (with codes supplied to Emergency Services).

d. Pedestrian (including wheelchair) access will be unimpeded via a 1.2m ungated path around the lefthand side of the gate (see attached drawing)

e. The new footpath and track also had to comply with comments made by the Fire Service during the preapplication consultation

2. I would be happy to attend one of the community council meetings in person or via Teams at a suitable date to answer any questions the community may have about our proposals
