2023/06 28 Consideration of Correspondence Received

- Email received from a member of the public, requesting Manorbier Community Council to consider the installation of electronic speed alerters in Lydstep To be added to the July Agenda for further consideration.
- Email received from the Planning Enforcement Officer Pembrokeshire Coast National Park Planning Authority, advising the Manorbier Community Council of the planning conditions connected to the Fish and Chip takeaway, in Jameston. This information was requested following several members of the public wanting clarity as to the planning conditions that have to be adhered to.
- Email received from the Legal Department of Pembrokeshire County Council regarding the recent installation of the portacabin at Jameston Village Hall for the use of the Manorbier School as extra learning space. The Portacabin is the property of Manorbier Community Council but will be leased, for a peppercorn rent to Pembrokeshire County Council until the school children can return to the school building. Manorbier Community Council to insure the building only.
- Telephone call received from the Legal Department of Pembrokeshire County Council advising that it was highly unlikely that the portacabin costs would be re-imbursed by the insurers but the costs to upgrade the heating system in the village hall, to meet Pembrokeshire County Council's Safeguarding Policy, would be.
- Email received from One Voice Wales advising of the grant funding being offered by the Government for Community ownership The Clerk advised that she would be attending a seminar on this topic later in the month.

2023/06 29 To receive County Councillor's Report

County Councillor Phil Kidney reported that -

- There has been an increase in fly tipping it has been noted that rubbish is being left by persons illegally parking overnight in various locations, not only in Manorbier, but the coastal areas throughout Pembrokeshire.
- It is noted that there is a disproportionate number of parking bays, allocated for Blue Badge users, at the Napp in Manorbier. Reserved bays are not being used and other vehicles, without Blue Badges, parking on the side of the road causing congestion Consideration to be given to decreasing the number of these bays.

2023/06 30 Action Tracking:

- a) Jameston Play Park Enhancing Pembrokeshire Grant Application in process Application submitted to Pembrokeshire County Council. Application has been approved in the sum of £14,097 Working party meeting to be held to discuss the final plans. As agenda item 2023/03 161- Order submitted, **Installation date awaited**.
- b) The installation of a defibrillator on the outside wall of the public toilets located within the Manorbier beach carpark Grant application to Save a Life Cymru for a defibrillator successful. Pembrokeshire County Council have advised that the Defibrillator cabinet can be located on the outside of the public toilet building. Insulated cabinet installed in Manorbier, Defibrillator awaited from Save a Life Cymru. **Defibrillator installed**.
- c) The installation of a defibrillator within Manorbier Newton It has been agreed to use the £1,000 gifted by the Long Course Weekend organisers. A location has been agreed. **Defibrillator and insulated cabinet installed**
- **d)** Beavers Hill Crossing (County Cllr Kidney) safety improvements and possible installation of road safety ramps/signs Cllr Kidney advised that works are to commence ASAP (March 2023)
