Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.

In 2022-23, the Council made payments totalling £ 5,500 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Camrose Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Amendment to opening balance

The value of balances brought forward at 1 April 2022 (Line 1 £6,733) is not equal to the balances carried forward at 31 March 2022 (line 7 £6,433). The clerk has incorrectly amended the opening balances to reflect the write back of an unpresented cheque as at 31 March 2022. The correct treatment is for the unpresented cheque to be written back as a deduction from expenditure in the year in which the cheque is cancelled. This is because the cancelled cheque is usually reissued and this process avoids double counting of expenditure.

We recommend that where the Council cancels a cheque, it records this as an adjustment to expenditure in year rather than amending the opening balances.

There are no further matters I wish to draw to the Council's attention.
