Minutes of the meeting of Stackpole and Castlemartin Community Council held at Castlemartin Community Church Hall on Monday, October 2nd 2023, at 7.30pm.

## **Update on current issues**

- 1. Llyr Wind Farms presentation about the Llyr Wind Farms by Ioan Jenkins.
- 2. Sustainable Freshwater west There are plans for redesigning the bottom car park and redevelop the toilets. The plans are going ahead as per plans details of the plans can be viewed on the National Trust website via the link Sustainable Freshwater West | Wales | National Trust. Rhian Sula of The National Trust will to provide an update on progress at November's meeting.
- **3.** Clerk CILCA Course The clerk is continuing working through the units slowly and is almost ready to submit the next module.
- **4. Councillor Training** Councillor Edward Morris will attend the training module understanding the law on the 11<sup>th</sup> October 2023.
- **5. Jason's corner heating** Solar panels have been installed on the show property number 8 along with air source heat pumps. The idea is that as each property is upgraded the tenants will be decamped into the show house while the works are completed. At the time of the meeting there was no further update.
- **6. Bosherston Quarry** The clerk has emailed the National Trust in relation to the signage for the quarry. The National Trust have installed signage which has already been removed by vandals. The clerk has emailed the National Trust and requested replacement signage and received an email to say the request would be passed on to the Stackpole office. Councillor Haydn Garlick will chase the matter up with the National Trust.
- **7. Spring in Road Stackpole** At the moment there does not seem to be an issue however the weather has been dry for a long time. The situation is being monitored but to date there has been no further issue.
- 8. Bosherston Speed Limit David Jarman attended the meeting to express concerns about speeding on the road from Bosherston to Broad Haven South beach. Currently once through the bottle neck the limit is 60 mph and as the village has become increasingly popular as a tourist destination a lot of visitors use the road to walk into the village with the current speed limit the road is very dangerous. The councillors asked the clerk to contact Darren Thomas of Pembrokeshire County Council to see if any further speed restriction can be imposed and request pedestrian signs either side of the bottleneck at the beginning of the beach road. Email received from Clare Williams of Pembrokeshire County Council detailing that Pedestrians in the carriageway sign – an order has been placed for two signs. *The pursuance* of a footway by the Councillors, however given the character of the road, the shared pedestrian / vehicle environment, the criteria within the guidance for setting speed limits, Clare suggested that this would be the safer and preferred cause of action. I.e. removing the potential pedestrian / vehicular conflict by separating the two distinct users. It is anticipated that following the changes to the legislation to enable the default speed on restricted roads to be lowered to 20mph, there will be new guidance provided. This may enable highway authorities to reconsider 30mph limits in other areas. Councillor Alderman has spoken to

- Simon Davies regarding permissive path inside field for campers to walk to village pub and café. Simon does not want to install a path.
- **9.** Castle Doc Woods Shed Councillor Haydn Garlick informed the community council that the National Trust will be upgrading the small shed in the car park at Castle Doc woods in Stackpole over the summer months. The work to replace the roof on the old shed and idy up the area will commence the week of the 9<sup>th</sup> of October 23.
- 10. Broad Haven South to Bosherston Village The councillors asked the clerk to write to the National Trust to request the installation of a footpath from Broadhaven South to Bosherston Village. The councillors asked the clerk to invite a representative from the National Trust to the next meeting in November 23.
- 11. Councillor Shirley Hammond-Williams Due to unforeseen circumstances Shirley has had to retire on the grounds of ill health. This leaves a vacancy on the Stackpole ward for one councillor any expressions of interest please email the clerk Rose Kennington via <a href="mailto:stackpolecastlemartincc.clerk@gmail.com">stackpolecastlemartincc.clerk@gmail.com</a>. Ther have been one interested partie John Shutt and Claire Strudwick has asked to come along to the meetings as she may have a potential interest in the vacancy. Both parties are from Bosherston.
- **12. Stackpole School** Agenda item for the services meeting Councillor Alderman to provide an update at next meeting in November.
- 13. Castlemartin Play Park Councillor Alderman to obtain funding to plant trees.
- **14. Stackpole Car Park** The old school car parking area is being used as dumping ground. The councillors asked to clerk to complain to Pembrokeshire County Council.
- **15. St Twynnells 20mph Speed Signs** The signs have been positioned on the side of the grass verge fifteen foot apart and could easily be knocked by passing tractor or lorry. Councillor Morris asked the clerk to write to Darren Thomas of Pembrokeshire County Council.
- **16.** Cow Shed Hill Road Signage The councillors asked the clerk to contact Darren Thomas of Pembrokeshire County Council and request signage to reflect the bad bends and T Junction at the top of Cow Shed Hill coming from Castlemartin.
- **17. Banageston Drains** The councillors asked the clerk to contact Darren Thomas of Pembrokeshire County Council to look at the drains on the road near Bangeston Farm as one of the drains is sunken and water all over the road.
