 Village Hall account and must be re-imbursed by Freystrop Community Council
- Vehicle parking on kerb/roadside outside An Trabhan, Post House & Bathesland
 - PCSO Adam Thomas has responded to the an enquiry for advice. Without line markings on the road it can be parked upon and the pavement parking can be viewed as attempts to keep the road clear even though it can inconvenience users of the pavement. It was suggested that PCC be contacted to apply double yellow lines and bring the road and pavement under the jurisdiction of traffic wardens. The clerk was requested to contact PCC
