# 1. Chairperson's Welcome

The Chair welcomed the Councillors to the meeting.

### 2. Apologies for Absence

Apologies received from Geraldine Campbell.

S Green and D Clements informed the Council that they will be late arriving.

#### 3. Declaration of Members' Interests

B Thomas has rights over the ground where there is planning for Osprey nests.

### 4. The Minutes

Minutes from July 2023 were read and agreed.

### 5. Matters Arising

• New member

New member, William Griffiths, signed the Declaration of Acceptance of Office.

### Defibrillator

To check that the defibrillator is working you need to open the door and check that there is a green flashing light.

Building site in the Rhos to be made into green site

Building material from the construction of 2 new houses on the former garden centre in the Rhos has been left on an empty plot. There is however a planning condition that this be made into a green site now that construction has been completed and the houses/plots have been sold.

This will be investigated by a planning officer at PCNPA.

• Drainage in the Rhos leading into new car park

There is excess water draining into the new car park site by the Rhos hall.

#### • Fly tipping in the Rhos

There is now more fly tipping near Hill block.

Fly tipping on the Belts that was reported at the beginning of August has not yet been cleared.

This needs to be reported again on the PCC My Account website. D Clements will also raise with PCC.

### Boundary review

Currently there is 1 Councillor for every 72 electorates.

The goal of the review is to have 1 Councillor for every 80—120 electorates.

Changes will be implemented in May 2027.

# • 20mph signs

Setting local speed limits in Wales and Traffic advisory leaflet presented to the Council.

Guidelines set out in these documents explain that all villages (20 or more houses and at least 600m in length) should be 30mph.

The Rhos has 24 houses. There are 3 street lamps which are less than 183m apart.

Highway authorities have a duty to erect and maintain the correct speed limit signs.

There are no 30mph signs in Uzmaston or in the Rhos.

D Clements has raised with Clair Williams, Traffic and Road safety engineering officer at PCC. PCC agreed to do a review of the speed limits in the Rhos and Uzmaston at the end of the financial year.

There is a meeting on 23<sup>rd</sup> October which Councillors can attend.

• Homelessness at the trim trail site at the end of the Floric

Concerns raised about sanitation issues and begging at the site. There have been homeless people camping there for several months.

This is in breach of planning, D Clements will request an update from PCC.

#### Chicane at the top of the New Road

There are marks from vehicles braking at the site. Concerns that the site has become more dangerous. There is parking on both sides of the road making the road very narrow.

This could be raised with the Rural Crime Team next month, photos will be taken of the site prior to this.
