Cleaver. A branch had fallen off recently after many years of hanging on. The tree is owned by Picton C

astle, it was noted that it was of high aesthetic and cultural value as well as a high ecological value and

was well know and loved locally, the spot where it is located is regularly visited and is considered to be

'iconic'. The tree is protected by a Tree Preservation Order with the National Park. The tree has some

defects which over time lead to likely failings in extreme weather. It is a very low risk environment.

The most likely risk of harm is to static vehicles parked beneath it. The suggested method of risk

management is to place

some form of bollards to preent people parking within the closest canopy area. It was also suggested that it would be an attractive cultural benefit to install an information board at the same time as any bollard type treatment, advising public of cultural and historic significance of the tree (it is believed that it was intentionally grown to that shape to make a ship's rudder) and an explanation of its health and life span etc., Enquiries will be made with Picton Castle and PCNPA to see if there is any practical or financial support for the bollards or information boards. Email response has been sent via Cllr Lewis.
