Discussion with Community Police Officer about parking problems around Village

Members welcomed to the meeting Police Community Service Officer Paul Mayhew. He initially outlined the areas of responsibility of the team he works with. Then C’llr Barbara Summons raised the issue of obstructive and inconsiderate parking in the Village. Pavement parking is not actually an offence. It is only normally dealt with by the Police if a pedestrian is forced off the pavement. The problem was mentioned of the parking in some places around the Village, such as in some parts of West Street, and at the bottom end of Front Street, especially in the evenings, such that it would be difficult or impossible for emergency vehicles to get through. P.C.S.O. Mayhew undertook to look at the problem in the evenings, and try and informally deal with any issues identified. He also mentioned the monthly community meeting at 7-30 every 2nd Thursday monthly in Johnston Community Hall, at which ongoing issues were discussed. Following the discussion, Members thanked P.C.S.O. Mayhew for attending, after which he left the meeting.

Matters Arising

Dog fouling. Nothing more had been heard from the dog warden regarding patrols. Members mentioned that the problem is worse than ever. Clerk to make contact again with the dog warden to ask her to attend.

The Beacon. The Clerk had tried to contact David Dixon without success. C’llr Rhys Jones to visit him, and inform Clerk of outcome of visit. Clerk to pass telephone number to Rhys.

Watery Lane. Clerk had passed this on to P.C.C., and had received a holding reply.
