### Discussion of possible car parking license system for Village Amenity.

The Clerk outlined his recommendations on how to proceed with the licensing of the car park. This involved marking out parking spaces in the car park, with numbered spaces, these to be licensed out individually to users. Members were in favour of the idea in principle. Clerk to try and make up a plan of a suitable layout, and bring this to the next meeting. C'llr Roy Venables to weed-kill the area. Matter to be placed on October agenda for further discussion. 408
