#### **Matters arising:**

#### 1. New Clerk

Shan Williams accepted as new clerk.

#### 2. Angle school

Angle is represented on the shadow governing body. The head teacher has been appointed. The next step is to work out work force numbers for staffing. ACC should have been sent minutes of meetings but not yet received. ACC to contact local member of the shadow governing body with offer of support if needed.

#### 3. Footpath to West Angle Bay.

To date no further developments. ACC request investigation into available grants via

Welsh Assembly minister to fund the installation of an extension of footpath/cycle path from between village and West Angle car park.

# 4. War memorial plaque funding

Cllr Williams has applied for a grant from CADW for up to 70% of costs but still awaiting feedback. Apparently all funding needs to be agreed by Welsh Assembly minister.

Cllr Powell informed the council that James Parkin, NPA agreed funding for 4 visits by parking attendants. ACC to liaise over timing of visits and ask about notice of penalties.

# 8. Enterprise Zone.

Cllr Williams has drafted a letter to the Chair of the Enterprise zone which has been agreed by members. Copies will be sent to both the Assembly member and the MP for the area.

Funding has been issued to several groups already. Angle football club (lawn mower); Village Hall (IT equipment); senior citizens. Two further applications have been received. ACC felt that further information is sought before submission to Sun Edison.

## 2. Carters Green

Concern raised that the amended plans re hedge banks had not been passed back to ACC and about the potential danger of the stones placed on the verge. ACC to request clarification from PCNPA and Highways dept.

- 1. Cllr Hill attended a meeting about NPA's Local Development Plans which support the building of 5 affordable houses on available land. Any such developments will remain available ONLY for locals. However there was discussion about the definition of local. A similar exercise was explored a few years ago between the Angle Estate and Pembrokeshire housing. ACC would like to respond to NPA to look at this further and to say there is still a need for affordable housing in the village.
- 2. Cllr James has stepped down as ACC representative for Valero and the Power station. Cllr Richards has agreed to attend Valero community meetings and Cllr Brown the Power Station.
