7. County Councillor's Report

- ➤ Boundary changes in Wales will not take place so no amalgamation with Templeton as previously thought.
- ➤ Flooding by Fish Farm in Lampeter Velfrey two months ago deep mud across the road reported and dealt with the following day.
- > Red light on Blaencilgoed turbine has been turned off.
- ➤ Request for a kissing gate behind Marlais View will be installed in the next few months.
- > Tavernspite and Templeton schools are now a federation and one body.
- Lamp outside garden centre in Tavernspite has been fixed
- ➤ A second drainage hole has been opened up by the bridge in Lampeter Velfrey.
- Perrotts Wall, Ludchurch taken to planning David spoke up in his favour. Has been refused.
- > Tanners Lane repairs will be closed on 14th March.
- ➤ David has been pressing for a decrease in traffic speed in the villages (Lampeter Velfrey /Ludchurch /Princes Gate /Tavernspite). Monitoring wires have been in place in the villages and no speeding has been recorded. Pushing for 40 to be reduced to 30 in PG and Ludchurch.
- Resurfacing programme all edges on road from Tavernspite to Princes Gate will be repaired
- ➤ Wide load coming through on 25 April coming from Pembroke Dock to Penblewin.
- ➤ Flooding issue at Ludchurch Farm Council out two days later. From Ludchurch Farm to Ludchurch Cross.
- ➤ Debate on Thursday doubling the Council Tax on 2nd homes. Cllr Simpson asked for Councillors views.
- Several complaints have been received from villagers in Ludchurch of illegal dumping of building waste on land owned by Mr James, Chapel Fields, next to the village.
- ➤ Water Board work will take place on the road from Princes Gate to Ludchurch Cross closed on May 10th.
- ➤ Flooding in Ludchurch problem with the quarry there was an agreement that the caravan site was able to maintain the ditches going into Hideaway Farm there has been some delay but the ditches have now been cleared. There is no natural drainage.
