**16/042 Minutes of previous meeting:** The Minutes of the previous Ordinary Meeting were taken as read, and signed by new appointed Chairman Eynon as a true & accurate record.

**16/043 Matters arising**

**Historic Local Place Names:** Cllr Lewis to update the Council on this matter. Unanimously agreed to advance to next meeting.

**Public Noticeboards:** The Councillors discussed the prospect of siting an additional public noticeboard within the ward. Crosshands was identified as a possible site but it was unanimously agreed this was no longer a viable proposition as few residents stopped here as the premises were closed.
