#### Any necessary discussion of Village maintenance

## Discussion of footpath problems outside 12-18 Middle Street, Rosemarket

C'llr Rob. Summons had previously sent a message to P.C.C. asking for this matter to be looked into. The Clerk had also sent a message. C'llr Rob. Summons had received a response to say that the work was not considered urgent at this time. Matter to be left in abeyance for the time being.

#### Discussion of hedgebank removal, The Beacon

Members were informed that Mr. & Mrs. O'Boyle, 6, The Beacon, Rosemarket SA73 1JX, had removed a section of hedgebank on the joint boundary between their property and The Beacon, during work being carried out on their property. It was pointed out that there was nothing in the planning consent (ref. 13/0009/PA) preventing removal of the hedgebank. However, C'llr Roy Venables was of the opinion that it was a section of wall that had been removed, not hedgebank. He also thought it unlikely that there was any intention to try and create an access. Clerk to look into the matter to establish what is actually happening, and if necessary contact Mr. & Mrs. O'Boyle to ask for more information on their intentions.

<u>Any other business</u> Website. Members were informed that the new collaborative website was complete, and training was ongoing at present. The Clerk was planning to attend Pembs. Archives to get the training.
