## Minutes of the September monthly meeting

The minutes were accepted as an accurate record and signed by the Chairman (proposer C'llr Steve Davies, seconder C'llr Rhys Jones).

## Matters Arising

Dog fouling bin. The Clerk had reported the matter to P.C.C., and understood that it had been passed to the relevant department for action.
Grass-cutting, The Beacon. The Clerk had been unsuccessful in getting a contractor to carry out the work. C'llr Barbara Summons had spoken to one of the Lockes, who had said that they might be in a position to carry out the work. 'One-stop' was also noted as being a possibility. Clerk to approach them about possibly doing the work.
Bridleway. The Clerk had passed on the concerns over the condition of the bridleway surface. However, the Countryside section in P.C.C. had inspected it, and commented that it seemed acceptable to them.
Well-cleaning. Members were informed that the work was completed.
Chapel Lane. The Clerk had reported the matter to P.C.C., but held off from writing to the private householders due to a message received via C'llr Rob. Summons indicating that some work had been undertaken. However, Members still had concerns over shrubs growing out into the verge outside Minster Cottage, on the lane leading up to The Beacon. Clerk to send a letter to the owners of Minster Cottage regarding this matter.
