16/063 Minutes of previous meeting: The Minutes of the August Ordinary Meeting were taken as read, and signed by Chairman Eynon as a true & accurate record.

16/064 Matters arising

Historic Local Place Names: Cllr Lewis reported a copy of the map section pertaining to the area "Clyne" was currently being completed by an ex resident and he was looking forward to receiving the information shortly. Chairman Eynon reported he would be speaking to a resident regarding the area at Vallen and was hopeful to have an update soon. It was unanimously agreed to advance again to next meeting.

Public Noticeboards: Clerk reported she cannot extract information regarding hits to pages of Martletwy-PCC Town/Community Council website. County Cllr Lewis suggested would be possible to request this information from PCC. Clerk to action. Chairman Eynon reported both Lawrenny Arms, and Snooty Fox put up first Agenda's supplied. Defibrillator: Chairman Eynon reported the award of funding was imminent. Councillor Cole asked for confirmation of the percentage of funding awarded. Chairman Eynon confirmed it was 100%. The Good Neighbours committee have been asked to obtain 3x quotes for the electrical work. Chairman Eynon concluded this was not a problem and that once funding had been received, work would commence on seeking and training volunteers. He confirmed at least a dozen would be required. There was unanimous agreement from the Community Council this was all extremely good news. A discussion followed regarding the permanent placement of the Defibrillators and whether the soon to be empty phone box in Landshipping could be utilised. It was agreed an advantage of keeping a defibrillator in the phone box would be that it did not rely on the good will of a resident. Cllr Lewis expressed concerns as to the cost of upkeep. It was agreed the Clerk should request costs for the upkeep of the phone box from BT and also enquire from Zurich Insurance, the current insurer of the Community Council, as to whether locating it in the phone box would have an effect on the premiums.
