16/075 Minutes of previous meeting: The Minutes of the October Ordinary Meeting and October Extraordinary Meeting were taken as read, and signed by Chairman Eynon as true & accurate records.

16/076 Casual Vacancy: Chairman Eynon confirmed there had been only one application for the vacancy received within the time limit of the vacancy notice. Mr Michael Carpenter of Martletwy was welcomed to the Council. Proposed by Chairman Eynon and Seconded by Cllr Williams the council voted unanimously to co-opt Mr Carpenter onto the Council. Chairman Eynon welcomed Mr Carpenter to the meeting and invited him to join the Council at the table.

16/077 Matters arising

Historic Local Place Names: Cllr M Lewis confirmed map was progressing well. Clyne Farm was nearly completed and Backs Farm was finished. He also confirmed Stangs would be attended to by the end of the month. This work would bring Landshipping to completion. The map will then be passed to Chairman Eynon to complete Vallen Farm in Martletwy.

Public Noticeboards: Councillors confirmed there was no further developments with regard this matter. Messrs Crowther are continuing to work on the refurbishment of the sign removed and Clerk will request an update. Chairman Eynon asked Clerk for feedback on new signs. It was reported they are working well, though perhaps an extra post could benefit rigidity when affixing notices.

Defibrillators: Chairman Eynon reported to Council the 3 defibrillators had been ordered and were 100% funded by Big Lottery Fund and a British Heart Foundation Grant. Maintenance costs as previously agreed would be funded by the Martletwy Community Council. Chairman of the Good Neighbours Scheme has provided a breakdown of these costs. Chairman Eynon reported he hopes training for the use of the defibs will commence in January 2017. Mr Carpenter asked if sites had been confirmed. Chairman Eynon gave Mr Carpenter a brief synopsis of locations and detail. Cllr Lewis mentioned the pads supplied with the defib machines. Confirmed they can be used once. Cost for new set is £25. Chairman Eynon confirmed each machine comes with a spare set. They are then easy to order. Cllr Lewis recommended the Good Neighbours Scheme introduce a proper procedure for the ordering of any additional or replacement peripheries. Chairman Eynon will speak to the Chairman of the Good Neighbour Scheme to suggest and also arrange training upon receipt of the machines.

Adopt a BT Kiosk: Clerk reported on email correspondence with BT with regard adopting the Landshipping payphone kiosk. Emails show there is no additional cost implication to the council other than the £1 nominal payment. Clerk is still awaiting a response from the insurance company with regard to whether or not it will increase the current premium. Mr Carpenter suggested the possibility of looking into adopting Martletwy as well. Clerk to investigate whether it is on the proposed list of removals. Cllr Lewis suggested Clerk approach BT and PCC to see if an extension to the November deadline could be extended to give council the opportunity to make final decision at December meeting.

PCNP - Replacement LDP, Call for candidate sites.

Chairman Eynon reported Mr Steve Evans would like to put forward the land East of the Walks, Landshipping. Cllr Cole confirmed there was also another possible site and he would report it to the Clerk for inclusion on the submission form.

a. 16/0549/PA – One Planet Development Martletwy – Update. Clerk reported Notice of Objection had been made as per the final draft sent to Councillors. This was submitted electronically through the Planning Portal at Pembrokeshire County Council. Clerk further reported a letter had been received from PCC inviting Councillors to attend a Planning Meeting. This had been postponed as the application had not made it on to the final Agenda for the November meeting. Cty Cllr Lewis suggested it was more likely to be on the December Agenda.
