St Florence Community Council Meeting Held at Village Hall, St Florence

7.30pm on Tuesday 7th February 2017

Public Participation: Mrs J Muckleston expressed concerns about a broken seat by Brookside House, it was agreed that the responsibility for the seat does not lie with the Community Council. Also noted was an Interpretation Board that had come off the wall by the Old Mill, a dog waste bin that was very much needed by the Old Mill and concerns of tipping of building materials adjacent to the Concrete Road.

Mr Darren Evans spoke with regards to a proposed Summer Festival Event, he would like to put on in July/August time within the village, Mr Evans asked whether the Council would be able to help with the arrangements, all agreed very happy to help; great idea for the village. This will be put onto March Agenda.

Mr A Barlow and Miss J Boardman spoke regarding their concerns arising from floating embers from the village bonfire in November on the playing fields. They expressed the opinion that they felt the bonfire was too close to their house and would the council consider moving the fire further away for this year's bonfire celebrations in November. The Risk Assessment will be re-looked at and a least the power decision on the sighting of the bonfire will be made in good time for the next event.

Five residents living immediately adjacent to the proposed development at Ash Grove attended the meeting to discuss various concerns with regards to the proposed new development. The points discussed included: worries about ground water run off (storm water drainage), tree felling, access problems, and houses being oversized for the plots. They also felt that the, modern design of houses out of keeping within the conservation area of a medieval village. Discussions were lengthy and it was agreed that the Clerk will write a letter to the Planning Department, detailing the points and expressing the resident's concerns. It was also suggested that each of the residents write their own letters to the Planning Department detailing individual concerns.

4. Matters Arising for information only

- 4.1 Planting of spring bulbs The planting of 1000 bulds on the main road into the village has now been completed by the Councillors.
- **4.2** Fly Tipping County Cllr Kidney advised that the promised letters would be sent out to residents within one week of the date of the meeting.
- **4.3** Funding Updates Unfortunately the LNG funding is now out of date. The Welsh Church Fund (repairs to the roof) their meeting will be held on the 23rd February.
- 4.4 Clerks Probationary Period Clerk to adapt a copy of the model Contract from the existing template, which is then to be presented at the March meeting of the Council.
- 4.5 Village Hall Car Park A load of dust has been delivered to smooth off the surface of the additional parking area. Councillors felt that an additional load may be required to complete.

Girls and Boys football equipment has now been moved from the garage to Storeroom 4 in readiness to house the new tractor and mower. Some equipment has been left by the Cricket Club and a request had been received for this to continue. Following discussion Councillors voted for the removal of the left over equipment. The Chair will meet with Jonathan Edwards from the Cricket Club before the next meeting in March to arrange diposal.

- 6.1 Village Grass Cutting Tender The Council are very happy with works from our current contractors 'Smart Gardens'. It was agreed that their contract will run again for another year, it will be assessed in November 2017 for 2018 season.
- 6.2 Unsafe Fence on walkway between Parsons Green and Parsonage Inn The unsafe fence has now been removed. A replacement is not deemed necessary, agreed by all.

They also expressed their concerns about the over trimming of the hedge along the sports field that boarders Fiddlers Lane.  - * It has been agreed that Tenby Cottage Hospital will remain open as a 'Minor injury Unit' following the successful piloted last summer.
 - * Cllr Kidney agreed that with regards to the Ash Grove development, individual letters from residents will be much more effective than a petition from the local area.
