8. HIGHWAYS & RIGHTS OF WAY.

Cllr R. John said that he had recently walked on Moorland Road and found it to be in a dreadful condition with large holes, some of them down to the clay of the sub base and dips where the road level had sunk. He said he had contacted County Cllr M. John. Cllr M. John said that he had contacted Rob Evans at PCC to ascertain if repairs could be carried out. Cllr Thomas said that the contractors had nearly finished in the field, he had spoken to them last week and they had agreed that for the fete on the 20th May, they would lay hard standing in case of rain and would help to erect the marques. Cllr Thomas said he had written to the builder of the new house asking if he would put the coping stones on the entrance wall before the fete.

Cllr Utting asked about the provision of water for the fete and whether a permanent water supply should be provided. It was decided to discuss this at a later date

Cllr R. John asked about the compensation from Welsh Water for use of the playing field. Cllr Thomas said that he had prepared paper work for submission to the agents dealing with the matter, showing that a far larger area of land than originally thought had been used and the contractors had been on site for far longer than agreed.
