17/112 Minutes of previous meeting: The Minutes of the October Ordinary Meeting were taken as read, and signed by Chairman Eynon as a true & accurate record.

17/113 Matters arising:

Historic Local Place Names: Chairman Eynon reported still no movement on this. 3 maps still awaiting completion with local residents. He will chase. Advance to next meeting.

Adopt-a-Kiosk: Clerk further reported a response had been received from Western Power regarding power supply to kiosk. 17/120: Communication: Clerk reported the latest news from the Welsh Assembly Government's Superfast Broadband roll out. Explained some residents have access to fast speeds, whilst others, specifically in Landshipping, will not have access to any additional speeds at all. For examples, BT had decided not to put Fibre To The Premises (FTTP) in Landshipping as had been in scope for over 6 months, and for which all the fibre cables had been installed. Instead they opted for the cheaper option of Fibre To The Cabinet (FTTC). All houses would have benefitted from FTTP but now some will not have access to faster speeds at all. It was agreed by all this was a disappointing result for some.
