# 10. Reports from Councillors Representing Committees Including County Councillor's Report

Cllr Preston – County Councillor's Report

- An open discussion regarding the proposed increase in Council Tax took place. Pembrokeshire County Council will set the budget on March 8<sup>th</sup> 2018.
- Pembrokeshire County Council is preparing to maximise the amount of funding it can receive from the European Union as we prepare for Bexit. It is my understanding that all funding streams will come to an end in 2022.
- The Swansea Bay City Deal will see investment into Milford Haven and Pembroke Docks. In addition to this a scheme known as 'Homes as Power stations' will be rolled out. This project involves new build developments having the technology to generate their own fuel and contribute power to the National Grid.
- Pembrokeshire County Council are in discussions on how to make available revenue raised with the additional second homes Council Tax for community projects. Early indications are that this funding will be allocated via the current 106 Agreement route. In terms of the play park equipment, this could be an ideal opportunity to fund additional equipment.
