decline the £150 expenses payment, need to write a letter to the clerk stating that they do not wish to receive payment.

It was agreed that the clerk should draft a letter for Councillors to sign rather than individual letters from each Councillor.

 Consideration of 2 applications to be co-opted on to Lampeter Velfrey Community Council – It was agreed to speak to the PCC monitoring officer before proceeding any further.

## 8. County Councillor's Report

- As David is keeping members updated throughout the month via email he gave members a broader picture of what is happening in the county.
- The reports that rates could go up 28% have been taken out of context. Pembrokeshire still has amongst the lowest rates in Wales. Lots of work has been done with staffing with voluntary redundancies being offer and the offer being extended to over 55 year olds could see a reduction of around 200 staff.
- The move out of Haverfordia House is almost complete and staff should be out of Cherry Grove by next June. The savings between all of this could be around £1 million. Staff members have relocated and 'agile working' has now been introduced to County Hall
- > Tolls will end on the Cleddau Bridge at the end of March 2019.
- PCC is considering buying a building in Tenby currently occupied the retailer Peacocks.
- > The Old Ocky White building has been purchased for £250,000.
