Minutes of the meeting of Stackpole and Castlemartin Community Council held at Stackpole VC School on Monday, December 4th 2017, at 7.30pm.

## **Update on current issues**

- 1. **Broadband provision:** progress with Eluned Morgan AM has had a meeting with Open Reach a picture was taken of Eluned Morgan and David Edwards titled a tale of two cabinets.
- 2. **New Penrhyn VC School:** The new Penrhyn School is on target to open on the new site on the 8<sup>th</sup> Jan 2018. The first governor's meeting was held on 27<sup>th</sup> November 2017.
- 3. **Dog Fouling signs:** Two new signs required for the entrance and exit of the village and one for the church car park. The signs are currently being made and will be ready for collection in January 2018.
- 4. **Sunken drain in Stackpole:** The councillors asked the clerk to chase this matter up as a matter of urgency.
- 5. **Clerk's PAYE:** The clerk attended a One Voice Wales training course The Council as an Employer which was effectively training on community council clerks and PAYE information to be discussed at the next community council meeting in January 2018. It was agreed that the clerk register the council with HMRC and no further pay checks to be written.
- 6. **Community Council Website:** The clerk asked for photographs of Stackpole and Castlemartin for the website and Councillor Steve Alderman is to bring some in to the next meeting in January 2018.
- 7. **Speeding through Gilead:** Temporary Radar Police were seen in the area checking speeding a fortnight ago.
- 8. **Dip in the road at Stackpole:** The councillors asked the clerk to chase up this matter with Darren Thomas at Pembrokeshire County Council and to inform Darren that it was Dwyr Cymru that initially dug up the road.
- 9. **Sunken Road at Sampson Cross:** The clerk has reported the matter to PCC who stated they would look at repairing the hole as soon as possible. The councillors asked the clerk to chase this matter up with Darren Thomas at PCC as the hole still remains.
- 10. **Emergency Planning:** Councillor Margot Bateman raised the issue of emergency planning having recently attending a workshop Margot requested that the councillors all think of ways to have the villages prepared in the event of an emergency. This is to be discussed at the next meeting in January 2018.

- 11. Freshwater West Bridge: Councillor Alderman asked the clerk to write to the highways department at PCC and request a weight sign with a red triangle to prevent heavy vehicles going down over the bridge and send a copy to Angle Community Council.
- 12. **Fence at Woodland Rise:** The councillors asked the clerk to chase this up again as the fence of the property opposite 4 Woodland Rise has not yet been repaired.
- 13. **Chapel Hill Hedge:** The hedge at Chapel Hill requires cutting back the councillors asked the clerk to write to PCC and request this hedging is cut back.
- 14. **Road Sweeping:** Councillor Peter Nicholas asked the clerk to write to PCC and request a road sweeper to sweep the roads at Freshwater East Hill from Trewent, Cheriton Stackpole and River Hill Stackpole.
- 15. **Social Care & Well Being Act:** Councillor Margot Bateman mentioned the Social Care & Well Being Act and asked that we all think about vulnerable people left on their own, suicide, drop in centres and empty properties.
