Update on current issues

1. **Stackpole VC School**-sale no further updates. Cabinet member David Lloyd has been replaced by Councillor Woodham from Milford Haven. Lord Cawdor will be coming down in the near future.

2. **St. Twynells Bus Shelter** –. Helen McLeod-Baikie is looking into the cost of the lease.

3. **Buckspool Farm Pot Hole** – Councillor Steve Alderman will speak to Simon Davies regarding filling in the pot hole.

4. **Street Lights** –The streetlight opposite Windsor House in Castlemartin has not yet been repaired Councillor Steve Alderman to report the issue using my account on the PCC website and detailing the lamppost identity number.

5. **Fly Tipping** – The fly tipping has been dumped on the right hand side at Lyserry has been cleared.
