1. APOLOGISE ; Cllr N.Coles \& D.Philpin
2. DECLARATION OF INTERESTS; None declared.
3. QUESTIONS FROM PUBLIC ; None been received.
4. MINUTES OF THE PREVIOUS MEETING ; The minutes of the previous meeting were passed as a true record, proposed by CIIr M.Galdo and seconded by ClIr T.Roberts.
5. MATTERS ARISING;

Car Park Sign ; Cllr D.Philpin not present to confirm if he has obtained a quote from PCC. Mrs D Davies asked to obtain a quote from Forrest printers before next meeting.
Defibrillator; Cllr S.Davey confirmed that pads been replaced, Batteries will need replacing July 2019. Cllr R.Owens has offered to apply for a grant to enable the village to gain up to a further 3 or 4 Defibrillators. Posts on Green ; Cllr N.Coles not present to update us on when they will be removed.
Cycle path at Triplestone Estate; Contact to be made by D.Davies to Andrew Richards, Nat Parks stating our disappointment no Cycle path been installed and requesting compensation for the village to a figure of $£ \mathbf{2 0}, \mathbf{0 0 0} \mathbf{0 0}$. Also concern from committee that No Break in the water outlet been installed by developer, therefore they can forsee flooding problems.
D.Davies asked to deliver a copy to each house on Triplestone estate of email received by ClIr R.Owens from planning about the lighting and road completion at the estate to ensure that the residents are aware this is the responsibility of the developer to complete before he leaves the site.

Speed check results; Results stated that speed will remain at 30 through the village. Committee still have concerns and D.Davies asked to reply to PCC to ask them to reconsider particularly as ClIr R.Owens mentioned a statement from Welsh Assembly , "20 IS PLENTY " Pot Holes in Car park; Works has been completed at a cost of $£ 730$, the car park has been scraped back \& new chippings replaced.
Steps to Sandyhaven Beach ; Contact to be made by D.Davies to Anthony Richards, Nat Parks to find out when work will commence on the steps. Cllr T.Roberts asked that I also mention that the footpath from the turnstile to the steps is breaking way and is dangerous so will also need improvement.
CCTV Camera; Cllr M.Galdo confirmed this has been installed along with a notice to the public waring about prosecution if any findings of dog fouling.
