### 3. Confirmation of Minutes of the Last Meeting

The minutes of the meeting held on the 16<sup>th</sup> June 2014 were read and proposed as a true record by Steven Philipps-Harries and seconded by Yvette Bevan

It was agreed that the matting would need replacing and hopefully only the section directly under the swings could be actioned. - a. Vogt Solar and Solafields proposed extension to Fenton Solar Farm (emailed) councillors had been contacted by residents in the ward expressing the concerns listed: -

  - A letter had been received from the owner of Duggans Land expressing his dismay at the proposed extension
  - There seems to be no information available regarding the Community Fund. It was agreed that the clerk would email Sarah Brewer the liaison at the company to ask if it was possible for Vogt Solar and Solafields to meet with interested community groups to discuss the fund.

David Howlett advised that hedge cutting was on going in the ward at present and assured Robert that Clarbeston would be included. The sign for Clarbeston was missing by Four Winds in Knock. There was need for a give way sign on the Lamboro Road, between Clarbeston church and Clarbeston Farm.
