7. County Councillor's Report

Cllr Pugh reported:

- The Consultation period is open for persons to comment on the Pembrokeshire County Council' Local Development Plan
- Unfortunately Green Hill School is under temporary Special Measures with all staff working hard to remedy the situation before the next inspection
- Various roads in the area will be undergoing resurfacing works. Disruptions will be kept to a minimum.
- A village litter pick will be held within the next few weeks.
- Mike Harris Pembrokeshire County Council has confirmed that the bins have been removed from the Coop carpark due to an increase in fly tipping. He further advised that consideration will be given to replacing the bins after the Christmas period.

8. To consider the Bank Reconciliation and Budget Monitoring report for the Third Quarter Finical Year 2019/20
