4. **Chairman's Report**

Cllr Brace reported that:-

- the road sweeper is still not sweeping the village road and using the Bypass to move between Tenby and Saundersfoot.
- that the drains at St Anne's Church remain problematic, especially so in heavy rain. This problem is being investigated by Pembrokeshire County Council who are currently awaiting further information from the Gas Board.
- Unknown persons are filling two public rubbish bins with beer bottles, it has been confirmed by Pembrokeshire County Council that if this continues the bins will be removed.
- The Christmas light 'switch on' followed by mould wine, mince pies and carol singing was a well-attended event, enjoyed by all.
