

Minutes of the meeting of Stackpole and Castlemartin Community Council held at Castlemartin Community Hall on Monday, January 6th 2020, at 7.30pm.

Update on current issues

1. **Stackpole VC School-** There has been no further update since the report detailed in the last meeting minutes from David Edwards.
2. **St. Twynells Bus Shelter –** There has been no further update the councillors asked the clerk to contact Helen Mcleod-Baikie of Pembrokeshire County Council for an update.
3. **Buckspool Farm Pot Hole –** Councillor Steve Alderman will check the pothole at Buckspool Farm before the next meeting in February.
4. **Fly Tipping –** Councillor Alderman to provide an update.
5. **Pot Hole –** The councillors asked the clerk to contact Pembrokeshire County Council again to request the pothole to be repaired.
6. **Visually Assisted Sign -** The councillors asked the clerk to obtain quotations for the cost of a sign to be installed at the entrance of the village of Stackpole.
7. **The Pound Castlemartin –** Councillor Alderman will contact Rob Scourfield of Pembrokeshire Coast to see if there is any possibility of providing a new sign.
8. **Brownslade –** The matter has been passed onto Steve Benger of Pembrokeshire County Council. Councillor Steve Alderman will take photographs of the water accumulation at both Brownslade (Castlemartin) and Merrion to forward to Pembrokeshire County Council.
9. **St Twynells Play Area –** There was no update to cutting back the hedge going into the play area in St Twynells. The councillors asked the clerk to contact Pembrokeshire County Council again relating to this matter.
10. **Speeding at the Pound in Castlemartin –** There was no update at the time of the meeting. The Councillors asked the clerk to contact the police in relation to cars speeding around the Pound in Castlemartin.
11. **Sleeping Policemen –** Email received from Barbara Rapley detailing the matter has been passed to check traffic criteria and accident records however due to workload pressure this could take some time and from what information is already held it is unlikely to meet the criteria. When the review has been carried out a definitive answer will be given in due course.
12. The councillors asked the clerk to report to Pembrokeshire County Council the bent road sign at Chapel Hill and the road narrows sign just before the property Creature leading into Bosherton the sign is leaning against the hedge.
