- Temporary Road Closure 22nd July for 1 day at Ludchurch Cross to Rectory Lodge for works to be carried out.
- Septic Tank, Llanmill I think that all of the permissions have now been granted and the work should be able to proceed soon.
- Crematorium It is proposed to increase the fees at the Crematorium and use the money to upgrade the facilities on site. Any money in excess will be used to fund Public Protection, such as inspections for food establishments, etc.
