8. County Councillor's Report

- There was a problem with flooding again in Ludchurch 3 days before Christmas and the road was closed as it was considered a danger. A site meeting has taken place with representatives from the County Council (Legal and Highways) but it was difficult to establish the problem whilst the flood is on ongoing. Strong possibility that the problem is around the caravan park and the owner was somewhat evasive. Natural Resources Wales has also been out to look at the problem. The diversions in place as a result of the road closure have led to several near misses as the roads are narrow and not suitable for the increased traffic.
- ➤ It was confirmed that Princes Gate and Llanmill are not included in the LDP as they have been downgraded to settlements.
- ➤ The repairs between Princes Gate and Tavernspite have still not been done but hopefully will be before resurfacing takes place.
