The clerk was asked to forward the email to Darren Thomas and to ask if a 20mph speed limit could be imposed on this road, bearing in mind that Welsh Govt were now encouraging 20mph limits on residential roads and to request an update on funding for 'Quiet Lanes'. The clerk would also inform the resident of our actions.

- a) The storm drains at Neyland Vale on Military Road were blocked with mud from farm vehicles – Clerk to request PCC to clear them.
- b) Cllr J Howell had asked if council would support an extension of the path to Waterston from Hazelbeach as PCC and Egnedol were considering improving the bridleway behind the Ferry Inn to make it a multi-user

- c) path. Members were in full support of this project and the clerk would inform PCC's Countryside Access Officer.
- d) Cllr H Dyer referred to the Local Dev Plan relating to the proposed houses next to Hazelbank play area. He stated that several holiday homes were becoming full-time residential and there were too many vehicles on this road to support more from a further development.
