The following matters were raised:

- a) Cllr Mrs Jean Lloyd advised Members of a very sharp bend in Little Honeyborough where cars were travelling too fast and were driving into a resident's gate. She asked if PCC could be requested to put up SLOW signage and this was agreed. Cllr Lloyd to supply a plan showing the exact location.
- b) The junction of the road known as the 'mad mile' at its 'T' junction with Military Road was raised and the need for improved signage here as drivers were slowing down too late and driving into the hedge opposite. Cllr J Howell suggested that PCC be asked to install 'rumble strips' at this location to warn motorists of the junction ahead.
- c) The matter of delivery vehicles to the Sinclair Garage was also raised and the damage they are causing to the verge on the road to Glenowen.
