### 1. Chairman's Remarks

The chairman welcomed everyone to the meeting and commented on how lovely it was to see a full complement of community councillors for the ward.

## 2. Apologies for Absence

Apologies for absence were received from Di Clements (County Councillor).

### 3. Declaration of Members Interests

There were no declarations of members interests.

## 4. Confirmation of Minutes of the Last Meeting – 1st October 2020

Minutes of the meeting held on 1<sup>st</sup> October 2020 were confirmed as a true record. Proposed by Tim and seconded by Tracy.

### 5. Matters Arising There From

a. Highways Traffic Calming Projects Update:

Roberson Wathen – Pembrokeshire County Council (PCC) were no longer considering the chicane on the road out to the village. The Vehicle Activated Sign on the Bush Inn approach to the village would be purchased with the Highways grant. Once PCC had decided the exact improvements that they would allow, the residents would be contacted to seek their opinion of the proposals.

Bethesda: again, once PCC had decided the exact improvements, residents would be contacted to seek their opinions of the proposals.

Gelli: PCC were looking into speed restrictions for the area - residents would be contacted to seek their opinions of the proposals.

Llawhaden: no traffic calming measures had been discussed previously for Llawhaden, but now that there were 3 new community councillors for this area it was felt that if further grant funding became available it was suggested that PCC Highways consider a STOP sign at the T junction in the village. There had been many a near miss at this junction and the safety of residents should be considered.

- b. Christmas lunch 2020 update: The decision had been taken to cancel the lunch for this year in light of the Covid-19 pandemic. It was hoped that if the restrictions were lifted in the new year, that a function would be held when it was safe to do so.
- c. Llawhaden Playpark: there was no update at present, however as the play park was the responsibility of PCC that any suggestions should be made to them directly.
- d. Woodland Trust Tree Pack Update: 50 saplings had been delivered to Hugh's home to date, and more were expected during November. Tracy had visited the sports field and

advised the meeting that saplings had been planted at the field recently, however the grass had grown up around them and it would be difficult to plant saplings there without a little groundwork being actioned initially. It was agreed to place a request for ideas from residents in the next issue of the newsletter, to find out what locals would like to see at the field and any suggestions they might have.

e. History Noticeboards (Heritage Grants): Hugh had spoken to Mary Houseman (a local historian) regarding information for the noticeboards and she agreed to look into writing information for them. It was believed that the afore mentioned grant was no longer available, but Hugh would investigate this further.
