- a. Clarbeston Road Playground Update: the clerk had ordered the items required from Online Playgrounds, and the items would be delivered in due course. The Pembrokeshire County Council (PCC) department responsible for playgrounds have been informed of the progress, and they have advised that the community council should pay the invoices raised for the work to be carried out and then claim the monies from the PCC.
- b. Broadband update: residents of Wiston and Clarbeston Road should be reminded to sign up to the PCC scheme as there was a possibility this could be the next location to be considered for the scheme.

- b. Wiston Kiosk is still awaiting repair of the windows and it would need to be cleaned and painted before a defibrillator and heated cabinet would be purchased and sited in the kiosk. Thomas agreed to chase this up.
