

Minutes of the meeting of Stackpole and Castlemartin Community Council held at Castlemartin Community Hall on Tuesday, May 18th 2021, at 7.30pm.

Update on current issues

1. **Stackpole VC School-** New alarm system has been installed. Councillor Alderman to speak to Pembrokeshire County Council re the overgrown grounds.
2. **St. Twynells Bus Shelter –** Photographs have been passed onto Rod Thomas of Pembrokeshire County Council.
3. **Buckspool Farm Pot Hole –** Potholing is within the access itself and not within the carriageway. The ongoing surface water is a concern and the drainage in this area was checked, cleaned and repaired as necessary.
4. **Pot Hole Cheriton –** The pot hole still remains the councillors asked the clerk to contact Darren Thomas of Pembrokeshire County Council.
5. **Visually Assisted Sign –** Councillor Alderman is going to try and obtain funding for a VAS sign at the entrance to Stackpole Village.
6. **The Pound Castlemartin –** Councillor Alderman will obtain quotations to replace the cast iron sign.
7. **St Twynells Play Area –** The matter has been passed to environmental services of Pembrokeshire County Council.
8. **Army Tanks –** Councillor Steve Alderman to speak to Steve Harries regarding the complaints received about the tanks in Castlemartin.
9. **Water Though –** The water though has been added to the portfolio of the Cawdor Estate.
10. **Street Lights –** All street lights now working with the exception of the one between Jason's corner and the Stackpole Arms, Councillor Edwards to report to Pembrokeshire County Council.
11. **Venn Cottage –** The drain damage outside Venn Cottage in Merrian will continue to be monitored.
12. **Broadband –** The councillors would encourage anyone using the internet to register for the Government Broadband Upgrade Fund details can be at [Register | Broadband Upgrade Fund](#).
13. **Defibrillator –** The defibrillator at Stackpole Quay has now been replaced.
14. **Parking Stackpole Quay/Bosherston–** Councillor Alderman is going to make enquiries regarding installing yellow lines.
15. **Parking Freshwater west –** The councillors asked the clerk to contact the National Trust with regard to parking.
16. **Playhouse at 2 Woodland Rise –** There does not appear to be any public rights of way in this area so the issue of the tree house encroaching would seem to be a civil matter for the owner of the lane.

17. The noticeboard in St.Twynnells - requires repair, Councillor Edward Morris to ask Matthew Arnold to provide a quotation.

18. Horse & Rider Signs, Bosherton – Pembrokeshire County Council only provide these signs at public expense where there is significant equestrian traffic due to bridleways interlinking with public highways. Pembrokeshire County Council can provide signs in connection with commercial riding stables but these would have to be recharged to the owners.
