**36/21 Declaration of Interest :** None declared.

**37/21 Questions from the Public :** Resident from the village informed the council that they were needing to improve a pathway to their cottage for safety reasons.. The pathway crossed common land that they did not own.

**38/21 Minutes from last Meeting :**Minutes from previous meeting on 4<sup>th</sup> May were reviewed by the council , passed as a true record , proposed by Cllr.S.Davey and seconded by Cllr T.Roberts.

1. Triplestone Close : No update.
2. Speed Checks : No Update from PCC on when they will be collecting the speed data along the top main road in the village, clerk to chase up again. Clerk informed council that she has completed a PAVS grant requesting funds to purchase a solar speed sign .
3. Junction to Havens Park : No update
4. Sea Creek Road : No update .
5. Defibrilators: The Zoll machine still not been returned from manufacturer.
6. Beach Footpath: No update.
7. Beach Road : Clerk had costings for the bollard, she asked Cllr M.Galdo and N.Coles to help in the decision making to ensure that best option is made . Before purchase is made the council is still completing all checks with PCC and National Parks on ownership of this piece of land. There has been No updates from PCC on placing the yellow lines and no update from PCC on the passing bays along the stretch or road to the beach.
8. Village Green Status : Clerk will ask Cllr R.Owens to follow up his conversation with Mr Dunckley at PCC , especially now as one of the residents from the cottages along this stretch of land needs to complete improvement work to the path.
9. Car Park at Sandyhaven Beach : Cllr M.Galdo suggested that the car park needs some improvements to the surface. He will get quotes for 40 ton of chippings, Cllr N.Coles proposed this work needs to be completed and seconded by Cllr T.Roberts .
